IMPORTANT- Juniors MUST enter through the entrance by the pool or the main hotel entrance.

Juniors must be accompanied by an adult, 21 or over, when walking around the casino.

Rules and Guidelines:

1. Two Brackets will be 450 and Under and 451 and Up. Races will be 4/3 for the 450 and Under. 451 and Up will be a 5/4 race.
2. The format will be 9-Ball, with a double-elimination format. MUST CALL THE 9. The 9 does not count in the bottom racking corners.
3. BCA Rules will be in place.
4. No 3 foul Rule.
5. Flip for Break.
6. Alternate Break.
7. All Juniors must check in on Friday, July 24th, from 3:30 to 4:30 PM in person with a legal guardian.
8. The tournament room closes at 1:00 AM, according to Hard Rock Casino and Hotel Tulsa. Matches will be adjusted as needed.
9. Fargos will be pulled on July 20th to build a bracket. (if there is a significant change in Fargo from time of sign up to date of building bracket, player will be reviewed and put in the decided bracket)
10. The Juniors Tournament will follow the guidelines of the BCA State on proper attire during the tournament. Players must wear a collared shirt, Jeans, Slacks, or knee-length denim shorts (NO HOLES).

11. No coaching from the sidelines will be permitted. If the player has questions, we have designated Referees to help. Adults/Legally Authorized Guardians, if you are caught coaching from the sidelines, you will be asked to leave the playing area; matches could result in a forfeit.
12. Matches will have a 2-hour time limit. This is to help keep the tournament moving along.
13. The 45-second shot clock will be in play. Any player put on the clock will cause the opponent to be put on the clock as well. Players will be on their own to keep shots to a minimum. Should opponents determine shots consistently exceed the time, a referee can be called to observe and make the decision.
14. No changes after the draw! Once the brackets are drawn, no changes are allowed. The bracket will be posted on July 24th by 1 PM. If the player does not show, the match will be forfeited.
15. Payment may be made in person to TD or through CashApp. Refunds may be granted upon approval by the TD.
16. Unsportsmanlike conduct will NOT be tolerated and may result in EJECTION!
17. Date of Birth must be verified by a birth certificate, passport, or photo ID.
18. Adults/Legally Authorized Guardians must remain in the tournament area; failure to do so may result in forfeited matches.
19. The Bracket and Matches will be posted using Compusport. There will also be a paper scorecard for each match. The losing player needs to initial the paper to state that the score is correct. Paper score cards must be turned in TD.
20. Tournament Players are not allowed to enter mini-tournaments organized by OKBCAPL while still participating in the Juniors Tournament.
